

Sun City Lincoln Hills Lavender Friends Club

Bylaws

ARTICLE I. - Name

The name of this organization shall be: Lavender Friends Club, hereinafter referred to as “the Club”.

ARTICLE II. – Purpose

1. The Stated purpose of the Club:
 - A. Provide social activities and informational resources for the members of the Club in a safe and comfortable environment.
 - B. Raise awareness of LGBTQ issues in the Sun City Lincoln Hills Community
 - C. Provide help and assistance to the members and community.
 - D. Create a legacy for future Lesbians, Gay, Bisexual, Transgender and those in friendship who reside in Sun City Lincoln Hills community.

ARTICLE III. – Membership

1. Membership in the Club is open and restricted to all Association residents.

ARTICLE IV. – Meetings

Members will be provided advance notice of the time and location of all Club general membership, social, and Leadership Team meetings.

ARTICLE V. – Voting

The Leadership Team will be elected by the Club’s general membership.

ARTICLE VI. - Records and Reports

1. The Club is organized and will operate in full compliance with the Association’s governing documents, including the Club Information & Guidelines Handbook.
2. The Policies and Procedures document is binding on the Steering Committee and the membership and can only be modified by a vote of the membership.

3. The Club is responsible for internal financial transactions and records, including any tax responsibilities, and has the responsibility to report appropriate financial business to its members.
4. All Club governing documents, including any meeting minutes and financial records, must be available for review by any Club member in good standing.
5. The Club will maintain a current list of at least two Club contacts with phone numbers and email addresses, and submit it to the SCLHCA Room Booking and Club Coordinator.
6. Lists containing Club member information shall not be used for commercial, political or personal purposes not related to the business of the Club.

ARTICLE VII. - Club Dissolution

1. In the event that the Club dissolves, all remaining assets will be returned to Club members whose dues are paid up at the time of dissolution . Dissolution will not be initiated until all outstanding debts are satisfied.
2. Upon dissolution or abandonment of recognized club status, the Club should notify SCLHCA Lifestyle staff of its reasons for dissolution or status abandonment, and, in the case of dissolution, confirm the proper disposition of all remaining Club assets and liabilities.

ARTICLE VIII. – Amendments

Bylaw amendments must be approved by the Clubs general membership prior to being submitted to the CCOC for review and recommendation to the Association's Board of Directors for approval. They will become effective after final approval by the Association's Board of Directors.
